Statement of Rental Policy

Application: The application fee is \$40.00 per application. All occupants 18 or older must complete a separate application. If you are married you may use one application. We will verify your rental history, your employment history, credit and criminal history. Monthly income must be at least 3 times the rent. Applications must be filled out completely. If you are breaking your lease, being or been evicted, owe another rental property money or provide false information you may be rejected. Disclosure of the credit report is legal obligation of the credit bureau. Applications can be mailed to TLEC Services, ATTN: Rental APP, P.O. Box 111421 Nashville, TN 37222, if not completed at the time of showing. Checks should be made out to **TLEC Services**. **You will need to provide a copy of your driver’s license and a current pay stub.**

Approval: After you have been approved you will need to make an appointment to sign your lease and pay the deposit within 72 hours. **The deposit & first full months rent will need to be in the form of a money order or cashiers check.** No deposit will be waived. **The deposit shall be non-refundable once received by TLEC, until lease is fulfilled. IF THE APPLICANT HAS NOT SIGNED A LEASE, BUT A DEPOSIT HAS BEEN PAID TO HOLD A UNIT AND THE APPLICANT CANCELS, THE DEPOSIT SHALL BE USED TO PAY A CANCELLATION FEE EQUAL TO THE AMOUNT OF THE DEPOSIT.** You will also need to begin changing the utilities into your name for the start of the lease. No keys are given until lease starts and rents/deposits have been paid in full.

Pets: Only a few of our properties allow pets. The non refundable pet fee is \$300.00. All pets must be pre-approved through management before they are brought to the property. No pet under the age of six months allowed. Exotic animals are not allowed. We do not allow pets to visit even temporarily. If we find a pet at the property without a pet agreement you will be charged a \$300.00 non refundable pet fee plus \$10.00 a day until the pet is removed.

Rent Information: Rent is always due on the 1st of the month. The late fee of 10% of your current balance will be applied on the 5th and due immediately. Weekends and holidays do not delay or excuse Tenant’s obligation to pay rent timely. If rent is paid before the 1st of the month, it will be deposited on the next business day of the month unless you notify us in writing that you would like it to be held until the 1st of the month. No funds will be held after the 1st day of the month. If you are paying late rent after the 10th of the month you must submit payment in the form of a money order or cashier’s check. Parking: Only 2 vehicles (no boats/trailers or RV’s) per property are allowed on the majority of our properties. All vehicles need to have current tags and must be operable at all times. Please park in your driveway or garage.

Vacating: You must provide 30 day written notice, provide a forwarding address and return all keys. Carpets will be professionally steamed cleaned by at time of move out which will be taken from your deposit.

Our company does not allow any activity that may be a nuisance, offensive, noisy or dangerous. We will not tolerate any illegal or unlawful activity or any other activity that will obstruct, interfere with or infringe on the rights of the persons near the property. If you experience any of these activities please call the appropriate authorities or management.
